Removal and replacement of current chiller with Carrier Corporation high efficiency variable speed screw chiller.

8. Feature: The good, service, or construction has the following unique features, characteristics, or capabilities:

The proposed 23XRV 400T is a high efficiency Variable Speed Screw Chiller. This chiller can reach 70% motor load reduction. Most chillers can only reach 30%. This chiller is not subject to surging. The 23XRV will unload to 10% or 40 tons. Unloading is accomplished by slowing the motor down, no guide vanes, unloaders, or slide valves. The fact that capacity control is controlled directly by the motor speed allows us to capture maximum energy savings.

Additionally, the 23XRV can handle entering condenser water temperatures up to 105 degrees. This means if we lose our cooling tower cell this chiller has the ability to handle water temperatures than most. Centrifugal chillers would surge and shutdown.

Standardizing our chillers with Carrier will bring significant value in we are only working with one vendor. Currently we are working with two (2) separate vendors to keep our chillers running. HMC's experience has shown the current chiller the same size as the Carrier chiller can not meet the needs of the organization during the summer months.

Carrier Corporation is the only known company that installs Carrier commercial equipment, including the requested chiller, on the Island of Hawaii.

	9. Essential Features: How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work:					
	Standardizing our chillers with Carrier, similar to how we have standardized our AHU's, brings significant value to HMC by only having to train employees on one type of chiller.					
	Additionally, this proposed chiller has the ability to accept entering condensing temperatures of up to 105 degrees which allows us to run this chiller in the event we lose a cooling tower cell.					
	HMC has also experienced the current chiller, even being the same size as the Carrier chiller, the current chiller can not maintain our chilled water temperatures in the summer months.					
Finally, this chiller is significantly quieter than centrifugal chillers. This chiller will provide greater electrical savings for HMC over the life due to the ability of achieving 70% motor load reduction.
